Please note that once photographs, student names, and other identifying information is released in any public forum, Edmonton Public Schools cannot control the further distribution or use of the material by those who access the information.

**STUDENT TECHNOLOGY USE AGREEMENT**

For the purposes of BYOT (Bring Your Own Technology), "Technology" means a privately owned wireless and/or portable electronic handheld equipment that includes, but is not limited to, existing and emerging mobile communication systems and smart phones, portable internet devices, handheld entertainment systems, laptops, or portable information technology systems that can be used for word processing, Internet access, image capture/recording, sound recording and information transmitting/receiving/storing, etc.

Responsibility to keep the devices secure rests with the individual owner. John D. Bracco school is not liable for any device stolen or damaged on campus. If a device is stolen or damaged, it will be handled through the administrative office similar to other personal artifacts that are impacted in similar situations. It is recommended that devices are personalized, to help with identification, and protective cases are used.

Students and parents/guardians choosing to bring their own device must adhere to the Student Code of Conduct, as well as Board policies, particularly Internet Acceptable Use and Internet Safety.

Student access to technology in school is a privilege and may be revoked if a student fails to fulfill his/her responsibilities as a user of this technology and that many, but not all, of these responsibilities are outlined below. Students will:

- Use school facilities and equipment only for school related educational activities
- Use the Internet only for activities related to curriculum expectations
- Adhere to copyright laws
- Not transmit material that is in violation of local, provincial or federal laws or regulations
- Refrain from sharing their user ID and password with anyone and will not use anyone else's user ID or password
- Access only personal files or those files to which they have been given permission to access by an authorized staff member
- Use only school approved software in compliance with licensing agreements
- Avoid monopolizing systems, overloading networks, and printing excessive materials
- Adhere to class specific guidelines as outlined by teachers
- Not create, use, display, or store any offensive, obscene, inflammatory or defamatory language or images that may negatively affect any other student or person
